Part A: Pupil premium strategy plan

Statement of intent

St. Nicholas Primary School is situated in the City of Hull near Hull University. It does not have a catchment area. It is a single form school housed in a Victorian building. Eligibility for free school meals has remained stable in recent years – 21% in 2017 – 2018 to 20.5% in 2021 – 2022. 41% of pupils live in the 28% most deprived households nationally (IDACI 2021).

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The school's most important priority is to close the attainment gap between our disadvantaged pupils and others within the school and nationally.

Quality first teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our pupil premium strategy for improving the attainment and progress of our disadvantaged children and all children is based on the guidance identified in the Education Endowment Foundation/using your Pupil Premium effectively. It will also involve plans to effectively use money from the National Tutoring Programme. Therefore, this strategy is an integral part of our school improvement plan and focuses on quality first teaching for every child.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.
